MCCA NAPL Remediation - Cypher Street

Project Background

 As part of the MCCA's soil monitoring program, Haley & Aldrich Engineering identified petroleum contamination below the surface of the roadway to a depth of approximately 15 feet, in a small portion of Cypher Street within the Massport Project area.

Soil Excavation

 The MCCA excavation of soils was conducted between Tuesday, February 20, 2024, and Wednesday February 28, 2024. All excavated soil was loaded directly onto trucks for proper disposal per DEP Regulations.

Dust Monitoring

- H&A maintained dust monitors in the work zone and, as requested by the community, at the three neighboring parks (A Street Park, Flaherty Park, and the Mahoney Community Garden).
- The monitors were in place by Tuesday, February 20, 2024, and were removed on February 27, 2024, when the remediation was completed.
- Except for alerts when the dust monitors were being calibrated, no significant alerts were encountered during remediation.


- MCCA will be setting up a separate Committee outside of BCEC Beautification Advisory Committee Design & Construction
